





#### Did You Know?...A California Policy Update

An update about California's plans for carbon neutrality from <u>Dr. Manijeh Berenji</u>, the Center's new Academic and Community Partnerships

The California Air Resources Board (CARB) recently approved the final version of its 2022 Scoping Plan for Achieving Carbon Neutrality. The Scoping Plan is a strategy CARB develops and updates every five years, as required by Assembly Bill 32 (the California Global Warming Solutions Act of 2006). The statute required by California law sets targets for percent reductions in greenhouse gas emissions.

The Plan notes the relationship between climate and health – specifically, that the health costs of climate and air pollution in the U.S. are well over

The 2022 Scoping Plan aims to reduce the state of California's own environmental footprint by having the State achieve carbon neutrality by 2045, through actions such as reducing demand for petroleum and building offshore wind capacity.

What are the potential health benefits of this Plan? With a reduction in emissions and therefore air pollution, there will be a significant decrease in the number of hospitalizations, lost workdays, and lost school days, equating to \$199 billion worth of economic savings, as stated by the Plan.

I myself am excited to see what comes of this Plan and what this means for climate action by the state!
